RENDALL MARTIN PAPERS

Notes on Collection

Biographical Note

Rendall Martin was the son of William Elliott Martin, a civil engineer and one time City Engineer for the city of Shreveport, and Lallie Booher Martin, born May 17, 1905. He graduated from Shreveport High School in 1923 and worked in civil engineering with his father for five years. In 1928 he started work in the Civil Engineering Department of the Arkansas Louisiana Gas Co. Later he became Chief Clerk of the Plant Accounting Department.

Scope and Content Note

About 75% of these records document the gas and public utilities in the Ark-La-Tex from the 1930's through the 1970's. The greater part of these records reflect the activity of the Arkla Gas Company and its Plant Accounting Department, though there are materials on Arkla's predecessor companies and the oil and gas industry in the area dating from 1906. Cadastral maps plotted for Arkla Gas Company as well as land survey, geological survey, parish, city and street maps are included in the records.

Gas and public utility records consist of cost studies, accounting cases, job descriptions, annual reports, copies of related legislation, legal opinions and publications of the Federal Power Commission and the National Association of Railroad and Utilities Commissioners. Also included are pamphlets, articles and clippings on the industry.

Included also are materials related to the Louisiana State Federation of Labor, 1916 - 1942, to the Booher-Martin Family and to other topics of historical interest in the Ark-La-Tex.

Notes on Arrangement

Record Groups I-V contain Gas, Oil and Public Utility Records arranged chronologically within each group. Group I contains various type records of several area gas and utility companies. The material on any one company tends to be meager. Group II contains material from regulatory agencies such as Federal Power Commission opinions and system of accounts. Also included is material from the National Assoc. of Railroad Commissioners, the Securities and Exchange Commission and the Federal Communication Commission.

Group III contains ten folders of records mostly annual reports from state and local public service commissions and departments of public utilities.

Group IV is comprised of Rendall Martin's Accounting Department records. These made up his working file and include a copy of the Natural Gas Act, procedural materials on classifying property, retirement units, definitions of terms and geological survey reports.

Group V includes speeches, articles and publications on the gas and oil industry.

Group VI contains 23 folders of materials on labor activity in Louisiana and of personal papers of Ernest H. Zwally, an active member of the Brotherhood of Painters, Decorators and Paper Hangers of America.

Notes on Collection - Page 2

Group VII is a collection of historical material related to oil and gas, the Booher-Martin Family and two items on Shreveport history. The Martin Family Papers comprise the largest of the three groups (60 folders) and they include 19th century letters, steamboat receipts, land grants and sales, as well as 20th century materials as war ration books, poll tax receipts, biographical and other genealogical material. Group VIII is a mixture of varied historical materials arranged chronologically.

The maps comprise a special part of the collection. Most of the maps are oil and gas maps of the Ark-La-Tex area or geological survey maps. The maps which are designated with an A are sectional maps of the area which denote ownership of oil and gas rights and which have been plotted at least partially by Arkla Gas Co. and numbered for their purposes. The original numbering of this map A-series has been maintained as closely as possible.

The photographs have been pulled and placed in the photograph collection. An individual list is found in the inventory. The photographs are primarily related to Henry H. Zwally with a few photographs of Shreveport landmarks.

More than 100 pamphlets or programs have been pulled and placed in the Pamphlet Collection. The bulk of these relate to Shreveport musical or theatre performances. A listing is found in the inventory.

The 87 postcards from the collection have been pulled, marked with the accession number and placed in the Postcard Collection. A list of the subjects of the postcards is included in the inventory.

Nineteen newsclippings have been pulled and placed in the Vertical File. An individual listing is found in the inventory.
