BIOGRAPHY

General and abdominal surgeon from Shreveport, LA.

Clarence Elmo Boyd was born on March 2, 1911, in Leesville, Louisiana. The son of Isaac Clarence Boyd and Ada Lee Stokes Boyd. He attended public schools in Leesville and DeRidder, Louisiana, before graduating from Austin (Texas) High School in 1928. He received the B.A. degree from the University of Texas in 1932 and the M.D. degree from the University of Texas Medical Branch at Galveston in 1935. He interned at Charity Hospital in New Orleans in 1935-1936. He did a residency at North Louisiana Sanitarium (now Doctors' Hospital) in Shreveport in 1936-1937. He was in the general practice of medicine in Shreveport from 1937-1942. In 1942 he opened the C.E. Boyd Clinic and limited his practice to surgery. In 1959 he became a founding director and chairman of the board of Doctors' Hospital. He was also a founding director of Shreveport Bank and Trust in 1958 and in 1963 became is chairman of the board. He retired from practice in 1989.

SCOPE AND CONTENTS

Correspondence, articles, speeches, clippings, printed matter, photographs, memorabilia, movie film, receipts, and index cards relating to the medical practice, professional activities, and political activism of Clarence Elmo Boyd. Includes material documenting Boyd's participation in numerous medical organizations, his career as a surgeon, outspoken opposition to chiropractic and socialized medicine, and support for conservative causes and politicians. Among the organizations in which Boyd actively participated are: American Medical Association, Louisiana State Medical Society, Shreveport Medical Society, Association of American Physicians and Surgeons, and American Society of Abdominal Surgeons. Major correspondents include: . The collection also includes a card index to his surgical cases.
